**Because the FAFSA uses prior-prior year tax data, even individuals who have an automatic six-month extension by the IRS should have completed their tax return by the time of verification. Therefore, they must verify income and tax information either by using the IRS DRT or by submitting to the institution an IRS Tax Return Transcript. Only parents granted an extension beyond six months may submit the following for verification.**

- A copy of an unexpired IRS approval of an extension beyond the automatic six-month extension if the individual requested an additional tax filing extension for the 2021 tax year (e.g., IRS Form 2350);
- Verification of Non-filing Letter (confirmation that the tax return has not yet been filed) from the IRS dated on or after October 1, 2022. **You can request a copy on-line at: <https://www.irs.gov/individuals/tax-return-transcript-types-and-ways-to-order-them> using the 4506-T form.**

**If you are unable to obtain a Verification of Non-Filing Letter from the IRS, please contact Lander University Financial Aid Office for additional instructions.**

- A copy of IRS Form W-2 for each source of employment income received for the 2021 tax year and,
- If self-employed, a signed statement certifying the amount of the individual's Adjusted Gross Income (AGI) and the U.S. income tax paid for the 2021 tax year.
