Vendor question 1. For the project IFB-SP-539-05-16-2024 Brookside Restroom Partial Renovations does the contractor need a plumbing license in order to do this project?

LANDER'S RESPONSE: As the project scope of work includes:

- 1. The procurement and installation of the multi-piece shower assembly
- 2. The disconnection and reconnection of water supply lines and drain lines for the shower
- 3. The disconnection and reconnection of water supply lines and drain lines for the vanity the contractor or applicable subcontractor will need to be in possession of the appropriate plumbing license and group, based on the value of the above work, as required by LLR, at the time of bid submission.
