- (b) Multiple Offers. Offerors may submit more than one Offer, provided that each Offer has significant differences other than price. Each separate Offer must satisfy all Solicitation requirements. If this solicitation is an Invitation for Bids, each separate offer must be submitted as a separate document. If this solicitation is a Request for Proposals, multiple offers may be submitted as one document, provided that you clearly differentiate between each offer and you submit a separate cost proposal for each offer, if applicable.
- (c) Responsiveness. Any Offer which fails to conform to the material requirements of the Solicitation may be rejected as nonresponsive. Offers which impose conditions that modify material requirements of the Solicitation may be rejected. If a fixed price is required, an Offer will be rejected if the total possible cost to the State cannot be determined. Offerors will not be given an opportunity to correct any material nonconformity. III. SCOPE OF WORK/SPECIFICATIONS

SCOPE OF WORK

Lander University is seeking contractors to provide charter bus service for the University's Athletic Teams (see section VIII. Bidding Schedule/Price-Business Proposal for team listings and planned schedule of games). Each successful Contractor shall furnish all buses, drivers, fuel, maintenance, and materials necessary for the trip. Travel will include departure from Greenwood (the University campus) to the destination(s) listed on the Bidding Schedule and returning to the University campus unless otherwise noted. Exact departure times shall be coordinated with the University designee in charge for each team as denoted on the attached Bidding Schedule.

These specifications describe standards of service for travel of Lander University students and personnel by bus transportation. These standards are intended to apply to all buses used for chartered bus transportation. The following requirements represent a minimum imposed by the University and these requirements, in no way, restrict the offeror from proposing additional or increased features.

Federal, State, University, and or NCAA regulations may change impacting social distancing and other safety standards. Groups impacted may include the athletics teams which would be transported as a result of an award(s) of this Invitation for Bid. In the event that a change in regulation takes place, an awarded contractor must notify the University immediately that it can meet or exceed the updated regulations. If an awarded vendor cannot meet or exceed a regulation, it must notify the University. No charge or penalty can be levied upon the University due to the cancellation of service if it can no longer meet the requirements of an added or changed regulation. No charge or penalty can be levied upon the University if Federal, State, University, and or NCAA regulations result in required cancellation of a trip or trips.

SPECIFICATIONS

A. Buses

- 1. Bus manufacture date shall not be older than fifteen (15) years.
- 2. Buses shall meet or exceed all applicable State and Federal Motor Vehicle standards.
- 3. Buses shall be equipped in accordance with all applicable State and Federal regulations and safety standards.
- 4. Buses shall be equipped with a VCR/DVD player with multiple screens.
- 5. Buses shall be equipped with wireless internet access.
- 6. Buses shall be equipped with locking storage for equipment and luggage underneath as well as overhead storage for personal bags.
- 7. Buses shall be capable of transporting at a minimum, the number of persons indicated for the trip WITH ability to store equipment and passenger gear as needed for stated number of persons on trip.
- 8. All buses shall be in good mechanical condition and be capable of transporting the minimum number of passengers as noted for each trip (52 passengers unless otherwise stated).
- 9. For buses with restrooms, restrooms shall be well maintained, clean, and well lighted.
- 10. Overhead rack space or space in back of the bus will be provided for coats, hats, etc.
- 11. **Temperature Control**: Where required for the comfort of passengers, buses will be equipped with air conditioning and heating units. The interior temperature of the bus will be controlled to ensure passenger comfort at all times regardless of seasonal weather conditions.
- 12. **Seat Specifications**: Passenger seats will be upholstered with foam rubber or other material providing equivalent comfort that has not shifted or is excessively worn and will prevent contact with structural parts of the seat bottom or back. Seats with shifted or excessively worn cushioning will not be acceptable, even if the seats otherwise meet the requirements herein.
- 13. **Cleanliness and Serviceability of Equipment**: Prior to departure of equipment from garaging point, buses will be serviced so as to be in proper operating condition. Interior and exterior will be thoroughly cleaned.
- 14. **Inspection:** The University reserves the right to inspect equipment prior to award.

B. Statutory Requirements

- Rules and regulations of the Interstate Commerce Commission, Department of Transportation, and State regulatory and supervisory agencies governing the safety of public motor transportation operations, condition of equipment, proficiency of operators and maintenance crews, and first aid requirements will be complied with at all times.
- 2. Offeror shall pay and maintain all licenses, permits, taxes, etc. which are or may be required by any and all regulatory authorities for the performance and satisfaction of this contract. Rules and

- regulations of all local, state and federal authorities which govern the safety of public transportation operations, equipment condition, proficiency of operators and maintenance personnel, and first aid requirements are to be complied with at all times.
- 3. Offeror must have and maintain a rating of "Satisfactory" through the Federal Motor Carrier Safety Administration.

C. Insurance

1. Contractor must carry a mandated minimum of \$5,000,000 of insurance coverage in accordance with the United States Department of Transportation Federal Motor Carrier Safety Administration regulations. Contractor must stay apprised of and abide by current mandatory minimum of insurance coverage requirements by Department of Transportation Federal Motor Carrier Safety Administration regulations. Contractor must also comply with the Insurance documentation requirements listed under the Insurance Section later in this document entitled Contractor's Liability Insurance. Prior to commencement of the work, contractor shall provide to the University a signed, original certificate of liability insurance (ACORD 25) as denoted in the Contractor's Liability Insurance subsection. This certificate must come directly from the insurance agency.

D. Drivers

- 1. Drivers shall be employed by the Contractor and dressed in uniform that identifies the company and driver.
- Contractor shall provide drivers who shall be fully qualified to operate the equipment and licensed accordingly as per all Federal, State, local and U.S. Department of Transportation laws, rules and regulations. Contractor must stay apprised of and abide by current statutory requirements for all drivers.
- 3. Lander University is a smoke free campus. No smoking will be allowed on the bus or on the University campus.
- 4. Drivers shall not eat, drink, smoke, read (including road maps or trip itineraries), write in log books, wear a headset/listening device, send or receive text messages, use a cell phone, or utilize a Bluetooth or other wireless phone device while operating the vehicle except in the event of a bona fide emergency. In all instances, drivers are expected to pull off the road before engaging in such activities.
- 5. Drivers shall not, under any circumstance, pick up any passengers during the trip that are not part of the University's approved travel group.
- 6. Drivers shall have prior knowledge of the trip itinerary and have a route planned. If the bus is equipped with an installed radio communication system or GPS or other navigation system, drivers trained in its safe operation may use such equipment in accordance with company policy.
- 7. Drivers shall be knowledgeable of preventive measures to keep inclement weather from adversely affecting scheduled trip.
- 8. Additional Driver: Due to the length of time required for travel on some trips, a second driver may need to be provided to be in compliance with current US DOT hours of service rules. As of 2017, Federal Department of Transportation safety regulations require that a driver not exceed 10 hours driving time and 5 hours on duty time, and after which the driver must have at least 8 hours of off time (not driving, not on duty). Contractor must stay apprised of and abide by current statutory requirements, and offer must include for relief of drivers if needed and/or required by law.
- 9. Any action by the driver while working on behalf of Lander University which results in

charges being incurred due to traffic citations, hotel room damage, etc. will be the responsibility of the driver or the carrier. Lander University will not be held responsible in these matters.

E. Routing/Scheduling

- 1. All trip mileage charges shall begin and end at the University's location.
- Departure Time Departure/Return times listed on the Bidding Schedule are estimates. Final
 scheduling for departure times and pick-up locations are the responsibility of the carrier, and should be
 made with the University Travel Coordinator.
- 3. **Arrival Time and Punctuality -** Punctuality and bus availability are vitally important (for instance, Athletic teams must not be late or absent from scheduled events due to NCAA regulations). Contractor shall arrive on the University's campus no later than one (1) hour **prior to** the departure time listed on the Bidding Schedule.
- 4. University shall provide the Contractor with an updated itinerary if a change is necessary, at a minimum of 24 hours before the departure date and time noted in this solicitation, unless the travel has been mandated in a change of schedule for reason out of the University's control.
- 5. Contractor shall forward a copy of the trip map route 24 hours in advance to the University Travel Coordinator in charge for each event.
- 6. Contractor will notify University Travel Coordinator of availability of WIFI access, power charging ports, and all other amenities available on specific bus assigned for trip.
- 7. Trips in excess of 200 miles from the University will be by the most direct route to destination to eliminate unnecessary road time. All return trips are straight through from place of departure.
- 8. Contractor shall include local travel at destinations listed within this solicitation (i.e. from the hotel to the restaurant, convention center, etc.). Contractor must transport groups to and from meals, and other locations as necessary.

9. Athletic Events:

- a. Athletic Events are subject to change based on schedule changes or inclement weather and may require a change in schedule or cancellation of scheduled trip. Any change will be provided as soon as information becomes available to the University designee as noted for each trip.
- b. Contractor shall include local travel at each of the athletic competitions listed within this solicitation (i.e. from the hotel to the stadium, restaurant, etc). Contractor must transport teams to and from meals, practices, and competitions as necessary.

F. Briefing of Passengers

- 1. Contractor will brief University Travel Coordinator in charge regarding route to be followed, stops in route and other service items. The University reserves the right to request changes, within reason, to the itinerary.
- 2. During the movement, the University Travel Coordinator in charge will be briefed concerning irregular events that occur and all reasons for delays or other interruptions to movement.

G. Cancellation by the University.

1. Trip cancellations are not anticipated, but are nevertheless possible. Any cancellation notice will be provided as soon as information becomes available to University person in charge. Should the University be required to cancel a trip with the Contractor, no penalty will be applied.

H. Approved Persons Only.

 Only the approved Contractor driver and University personnel and students are allowed on the buses during travel, unless an additional relief driver is required by law, which will require disclosure to the University.

I. Subcontractors

1. Contractor shall not subcontract coach bus service with another carrier under the terms of this contract or otherwise assign this contract unless approval is obtained from the Lander Procurement Services department during normal business hours Monday through Friday, 8:00 am – 5:00 pm by calling (864) 388-8276. If mechanical breakdown occurs outside of normal business hours during travel, the Lander designee for the applicable trip shall have authority to approve use of subcontractor occurring outside of normal business hours.

J. Standards of Service.

- General-The standards of service prescribed herein are a minimum and apply to all buses used under this procurement. In emergency situations carriers will endeavor to comply with the prescribed standards, as the circumstances permit.
- 2. **Departure Time-**Departure times and Returning times listed under Section VIII. (Bidding Schedule/Price-Business Proposal) are estimates. Final scheduling for departure times and pick-up locations are the responsibility of the carrier and should be made with the University's designee for that specific trip.
- Arrival Time and Punctuality- Punctuality and motor coach availability are vitally important, as athletic
 teams must not be late or absent from scheduled events due to NCAA regulations. The Contractor
 shall arrive on the University's campus no later than one (1) hour prior to the departure time prescribed
 on the provided itinerary.
- 4. **Baggage -** It is the responsibility of the carrier to properly load, unload and secure all baggage and to ensure that baggage compartment doors are properly secured. Lander personnel are responsible for unloading impediments (for instance: athletic equipment, etc.) as distinguished from personal baggage.
- 5. Mechanical Breakdowns Contractor must have sufficient fleet to compensate for mechanical breakdowns. Should mechanical breakdown or accident prevent continuation of trip with the original equipment, it shall be the Contractor's responsibility to provide alternate transportation that meets the specifications as outlined in this solicitation and make every reasonable effort to maintain original schedule. The procedures in place for roadside emergencies may be requested for evaluation purposes. Failure to provide procedure(s) upon request may result in rejection of your offer.
- 6. Inspection The University reserves the right to inspect and reject all vehicles used in executing this contract. Such inspection may include a review of State required maintenance records, safety equipment, tires, glass, general appearance and cleanliness, and any other area that could affect the safety and comfort of passengers. Inspection will also include observance of the Contractor's procedures for compliance with the stated Standards of Service and other stated Specifications. Material deficiencies shall result in a written cure notice or, at the determination of the University, may result in the immediate termination of the contract or reduction in the total contract price of up to twenty (20%) of the trip in question.

- 7. Each carrier will brief the Lander person(s) in charge regarding route to be followed, stops in route and other service items.
- 8. During movement the Lander person(s) in charge will be briefed concerning irregular events that occur and all reasons for delays or other interruptions to movement.
- K. Billing and Invoicing: The successful offeror shall ensure accurate routing of billing. Invoices must be sent to the Office of Procurement Services. Payment for services rendered shall be made monthly based upon valid and approved invoices submitted by the vendor to Lander. Each invoice must be itemized to clearly reflect contract rates and the following information:
 - Lander University department contact name and address
 - Purchase Order Number
 - Event Name If Applicable
 - Date And Time of Servcies

L. Additional Requirements:

- Offeror shall be given a written warning for the first material deficiency during the course
 of the contract with the University. Any subsequent material deficiency shall result in the
 form of a cure notice, plus a meeting with Lander's Procurement Director.
- 2. Team(s) will depart and return to the Finis Horne Arena, Lander University, or, JMC, Greenwood, S.C., at time specified in itinerary.
- Lander may add or delete games. Contractor will be notified as soon as information is available.
- 4. In the event the awarded bus contractor does not have a bus available for any given trip, it is the contractor's responsibility to obtain a bus.
- 5. In the event that Lander desires a one-day trip, but the contractor deems that the time/distance requires an overnight trip, Lander reserves the right to decline the charter and make other arrangements.
- 6. Games are subject to an extra day if weather forces cancellation of a game. All games are subject to changes based on inclement weather and may force an extra night's stay.
- 7. Post-season mileage is possible for trips to conference tournament. Not all mileage for the post season is included. Charter service will be needed for these games as playoffs are determined. It is understood that the same mileage rate will apply to <u>both</u> scheduled games and post season games and that an <u>amendment to puchase</u> <u>order</u> will be issued for actual mileage incurred to the post season games.
- 8. At a later date for purposes of social distancing or in the event of changed regulations (see Section III Scope of Work), the University may require a different capacity vehicle, or require additional vehicle(s) for the capacities which are requested to be quoted for any or all of the trips listed in Section VIII Bidding Schedule / Price Business Proposal. In the event that an awarded trip requires a different capacity vehicle, or requires additional vehicle(s) for a trip or

trips, the awarded vendor will be contacted with the updated capacity requirement. The awarded vendor will provide available alternatives to the University including any potential change in price. If an alternative is amenable to the University, the University will provide a change order to update for the corrected capacity and cost requirements for that trip or trips. In the event that the awarded vendor cannot provide an available alternative which meets the University's needs, that trip may then be cancelled by the University with no charge or penalty levied by the vendor due to the cancellation of the trip or trips. The University would not be interested in splitting individual trips between multiple vendors. The University would only accept a subcontracted vendor if in compliance with Scope of Work Section III, item I. Subcontractors.

- 9. **Note:** <u>all miles are approximate.</u> It will be the responsibility of the vendor bidding to compute exact mileage including any "dead" miles to be incurred.
- 10. A 52 capacity passenger bus is required.
- 11. Services to be designed and performed with a conscious emphasis on cultural sensitivity and competency, diversity, and respect.
- 12. Services will adhere to written policies and procedures governing the delivery of services, including compliance with federal, state or other applicable laws and regulations.
- 13. Contractor shall ensure no personnel working on the Lander campus, in any capacity, if they have a felony conviction for drug, alcohol, weapons, sexual offense, or any other violent crime.
- 14. FAMILY EDUCATIONAL RIGHTS AND PRIVACY ACT (FERPA): (a) Vendor warrants that it will not make available or distribute any student education records it receives from Lander in violation of the federal Family Educational Rights and Privacy Act (FERPA) 20 U.S.C. section 1232g. Vendor agrees to limit access to records provided by Lander to its employees with a legitimate need to know in order for Vendor to fulfill its obligations under this agreement. Vendor warrants that it has procedures in place to prevent unauthorized access to data provided by Lander and the procedures will be documented and available to Lander upon request. Vendor will notify Lander immediately in the event of a security breach that could or does impact Lander records or data. (b) Vendor agrees that Lander data will not be shared or sold to third parties without prior written authorization from Lander. Vendor agrees to notify Lander immediately if it receives a subpoena, court order or other request for Lander data so Lander can take appropriate action if needed.
- 15. The successful Offeror shall provide satisfactory evidence of all required insurance coverage and licenses PRIOR TO PERFORMANCE. Insurance in at least the amount as required by the Federal Motor Carrirer Safety Administration (liability and/or cargo) and as noted in Section III.C.1. The successful vendor must furnish copies of insurance certificates with the executed contract. Certificate must indicate that the insurer will make every effort to notify Lander within ten (10) days of cancellation of policy.
- 16. The vendor will hold Lander University harmless from any accident, incident, injury or claim incurred while performing the listed duties for Lander and will be solely responsible for any worker's compensation, unemployment compensation, or other payments as may be required by federal, state,

or local laws. The firm is also aware that they are not an agent of Lander or the State of South Carolina and its employees shall not be entitled to any benefits provided by either.

- 17. This contract is not seller's authority to produce and deliver and does not obligate buyer to purchase. Authority to produce and deliver against this agreement is granted only by a purchase order.
- 18. Base response on the following sports travel itineraries* received to today's date. More trips may be added and use of contract is for any area or department of Lander University needing bus services. Please note that some trips may be cancelled or taken in vans and bus services are not needed.

The University will:

- A. Provide a designee to coordinate all departure times and locations for pickup.
- B. Provide an adequate parking site for departure.

The foregoing restriction does not apply to a transfer that occurs by operation of law (e.g., bankruptcy; corporate reorganizations and consolidations, but not including partial asset sales). Notwithstanding the foregoing, contractor may assign monies receivable under the contract provided that the state shall have no obligation to make payment to an assignee until thirty days after contractor (not the assignee) has provided the responsible procurement officer with (i) proof of the assignment, (ii) the identity (by contract number) of the specific state contract to which the assignment applies, and (iii) the name of the assignee and the exact address or account information to which assigned payments should be made. (b) Unless otherwise provided herein, including the purchase order, payment will be made by check mailed to the payment address on "Page Two." (c) Notwithstanding any other provision, payment shall be made in accordance with S.C. Code Section 11-35-45, or Chapter 6 of Title 29 (real property improvements) when applicable, which provides the Contractor's exclusive means of recovering any type of interest from the Owner. Contractor waives imposition of an interest penalty unless the invoice submitted specifies that the late penalty is applicable. Except as set forth in this paragraph, the State shall not be liable for the payment of interest on any debt or claim arising out of or related to this contract for any reason. (d) Amounts due to the State shall bear interest at the rate of interest established by the South Carolina Comptroller General pursuant to Section 11-35-45 ("an amount not to exceed fifteen

percent each year"), as amended, unless otherwise required by Section 29-6-30. (e) Any other basis for interest, including but not limited to general (pre- and post-judgment) or specific interest statutes, including S.C. Code Ann. Section 34-31-20, are expressly waived by both parties. If a court, despite this agreement and waiver, requires that interest be paid on any debt by either party other than as provided by items (c) and (d) above, the parties further agree that the applicable interest rate for any given calendar year shall be the lowest prime rate as listed in the first edition of the Wall Street Journal published for each year, applied as simple interest without compounding. (f) The State shall have all of its common law, equitable and statutory rights of set-off. [07-7A055-3]

PURCHASE ORDERS (JAN 2006): Contractor shall not perform any work prior to the receipt of a purchase order from the using governmental unit. The using governmental unit shall order any supplies or services to be furnished under this contract by issuing a purchase order. Purchase orders may be used to elect any options available under this contract, e.g., quantity, item, delivery date, payment method, but are subject to all terms and conditions of this contract. VII. TERMS AND CONDITIONS -- B. SPECIAL

CONTRACTOR'S LIABILITY INSURANCE - GENERAL (FEB 2015) (a) Without limiting any of the obligations or liabilities of Contractor, Contractor shall procure from a company or companies lawfully authorized to do business in South Carolina and with a current A.M. Best rating of no less than A: VII, and maintain for the duration of the contract, insurance against claims for injuries to persons or damages to property which may arise from or in connection with the performance of the work and the results of that work by the contractor, his agents, representatives, employees or subcontractors. (b) Coverage shall be at least as broad as: (1) Commercial General Liability (CGL): Insurance Services Office (ISO) Form CG 00 01 12 07 covering CGL on an "occurrence" basis, including products-completed operations, personal and advertising injury, with limits no less than \$1,000,000 per occurrence. If a general aggregate limit applies, the general aggregate limit shall be twice the required occurrence limit. This contract shall be considered to be an "insured contract" as defined in the policy. (2) Auto Liability: ISO Form Number CA 00 01 covering any auto (Code 1), or if Contractor has no owned autos, hired, (Code 8) and non-owned autos (Code 9), with limits no less than \$1,000,000 per accident for bodily injury and property damage. (3) Worker's Compensation: As required by the State of South Carolina, with Statutory Limits, and Employer's Liability Insurance with limit of no less than \$1,000,000 per accident for bodily injury or disease. (c) Every applicable Using Governmental Unit, and the officers, officials, employees and volunteers of any of them, must be covered as additional insureds on the CGL policy with respect to liability arising out of work or operations performed by or on behalf of the Contractor including materials, parts or equipment furnished in connection with such work or operations. General liability coverage can be provided in the form of an endorsement to the Contractor's insurance at least as broad as ISO Form CG 20 10 11 85 or if not available, through the addition of both CG 20 10 and CG 20 37 if a later edition is used. (d) For any claims related to this contract, the Contractor's insurance coverage shall be primary insurance as respects the State, every applicable Using Governmental Unit, and the officers, officials, employees and volunteers of any of them. Any insurance or self-insurance maintained by the State, every applicable Using Governmental Unit, or the officers, officials, employees and volunteers of any of them, shall be excess of the Contractor's insurance and shall not contribute with it.(e) Prior to commencement of the work, the Contractor shall furnish the State with original certificates and amendatory endorsements or copies of the applicable policy language effecting coverage required by this section. All certificates are to be received and approved by the State before work commences. However, failure to obtain the required documents prior to the work beginning shall not waive the Contractor's obligation to provide them. The State reserves the right to require complete, certified copies of all required insurance policies, including endorsements required by this section, at any time. (f) Should any of the above described policies be cancelled before the expiration date thereof, notice will be delivered in accordance with the policy provisions. In addition, the Contractor shall notify the State immediately upon receiving any information that any of the coverages required by this section are or will be changed, cancelled, or replaced. (g) Contractor hereby grants to the State and every applicable Using Governmental Unit a waiver of any right to subrogation which any insurer of said Contractor may acquire against the State or applicable Using Governmental Unit by virtue of the payment of any loss under such insurance. Contractor agrees to obtain any endorsement that may be necessary to effect this waiver of subrogation, but this provision applies regardless of whether or not the State or Using Governmental Unit has received a waiver of subrogation endorsement from the insurer. (h) Any deductibles or self-insured retentions must be declared to and approved by the State. The State may require the Contractor to purchase coverage with a lower deductible or retention or provide proof of ability to pay losses and related investigations, claim administration, and defense expenses within the retention. (i) The State reserves the right to modify these requirements, including limits, based on the nature of the risk, prior experience, insurer, coverage, or other special circumstances. [07-78056-2]

CONTRACTOR PERSONNEL (JAN 2006): The Contractor shall enforce strict discipline and good order among the Contractor's employees and other persons carrying out the Contract. The Contractor shall not permit employment of unfit persons or persons not skilled in tasks assigned to them. [07-7B060-1]

The Contractor certifies that its employees, volunteers, and participants are not registered sex offenders and have not been convicted of a felony. The Contractor will be responsible for compliance with Title IX and Title VII of federal civil rights laws while on University property or while conducting associated activities off University property. Failure to comply with the above may result in unilateral and immediate revocation of this contract.

The use of all tobacco products is prohibited in or on all University property. Tobacco products include all forms of tobacco and smoke-related products, including but not limited to, cigarettes, cigars, pipes, chewing tobacco, snuff, water pipes (hookahs), bidis, kreteks, smokeless tobacco, electronic cigarettes and other devices allowing for the ingestion, combustion, inhalation or other use of tobacco.

CONTRACTOR'S OBLIGATION – GENERAL (JAN 2006): The contractor shall provide and pay for all materials, tools, equipment, labor and professional and nonprofessional services, and shall perform all other acts and supply all other things necessary, to fully and properly perform and complete the work. The contractor must act as the prime contractor and assume full responsibility for any subcontractor's performance. The contractor will be considered the sole point of contact with regard to all situations, including payment of all charges and the meeting of all other requirements. [07-7B065-1]

DEFAULT (JAN 2006): (a) (1) The State may, subject to paragraphs (c) and (d) of this clause, by written notice of default to the Contractor, terminate this contract in whole or in part if the Contractor fails to: (i) Deliver the supplies or to perform the services within the time specified in this contract or any extension; (ii) Make progress, so as to endanger performance of this contract (but see paragraph (a)(2) of this clause); or (iii) Perform any of the other material provisions of this contract (but see paragraph (a)(2) of this clause). (2) The State's right to terminate this contract under subdivisions (a)(1)(ii) and (1)(iii) of this clause, may be exercised if the Contractor does not cure such failure within 10 days (or more if authorized in writing by the Procurement Officer) after receipt of the notice from the Procurement Officer specifying the failure. (b) If the State terminates this contract in whole or in part, it may acquire, under the terms and in the manner the Procurement Officer considers appropriate, supplies or services similar to those terminated, and the Contractor will be liable to the State for any excess costs for those supplies or services. However, the Contractor shall continue the work not terminated. (c) Except for defaults of subcontractors at any tier, the Contractor shall not be liable for any excess costs if the failure to perform the contract arises from causes beyond the control and without the fault or negligence of the Contractor. Examples of such causes include (1) acts of God or of the public enemy, (2) acts of the State in either its sovereign or contractual capacity, (3) fires, (4) floods, (5) epidemics, (6) quarantine restrictions, (7) strikes, (8) freight embargoes, and (9) unusually severe weather. In each instance the failure to perform must be beyond the control and without the fault or negligence of the

Contractor. (d) If the failure to perform is caused by the default of a subcontractor at any tier, and if the cause of the default is beyond the control of both the Contractor and subcontractor, and without the fault or negligence of either, the Contractor shall not be liable for any excess costs for failure to perform, unless the subcontracted supplies or services were obtainable from other sources in sufficient time for the Contractor to meet the required delivery schedule. (e) If this contract is terminated for default, the State may require the Contractor to transfer title and deliver to the State, as directed by the Procurement Officer, any (1) completed supplies, and (2) partially completed supplies and materials, parts, tools, dies, jigs, fixtures, plans, drawings, information, and contract rights (collectively referred to as "manufacturing materials" in this clause) that the Contractor has specifically produced or acquired for the terminated portion of this contract. Upon direction of the Procurement Officer, the Contractor shall also protect and preserve property in its possession in which the State has an interest. (f) The State shall pay contract price for completed supplies delivered and accepted. The Contractor and Procurement Officer shall agree on the amount of payment for manufacturing materials delivered and accepted and for the protection and preservation of the property; if the parties fail to agree, the Procurement Officer shall set an amount subject to the Contractor's rights under the Disputes clause. Failure to agree will be a dispute under the Disputes clause. The State may withhold from these amounts any sum the Procurement Officer determines to be necessary to protect the State against loss because of outstanding liens or claims of former lien holders. (g) If, after termination, it is determined that the Contractor was not in default, or that the default was excusable, the rights and obligations of the parties shall, if the contract contains a clause providing for termination for convenience of the State, be the same as if the termination had been issued for the convenience of the State. If, in the foregoing circumstances, this contract does not contain a clause providing for termination for convenience of the State, the contract shall be adjusted to compensate for such termination and the contract modified accordingly subject to the contractor's rights under the Disputes clause. (h) The rights and remedies of the State in this clause are in addition to any other rights and remedies provided by law or under this contract. [07-7B075-1]

INDEMNIFICATION-THIRD PARTY CLAIMS - GENERAL (NOV 2011): Notwithstanding any limitation in this agreement, and to the fullest extent permitted by law. Contractor shall defend and hold harmless Indemnitees for and against any and all suits or claims of any character (and all related damages, settlement payments, attorneys' fees, costs, expenses, losses or liabilities) by a third party which are attributable to bodily injury, sickness, disease or death, or to injury to or destruction of tangible property arising out of or in connection with the goods or services acquired hereunder or caused in whole or in part by any act or omission of contractor, its subcontractors, their employees, workmen, servants, agents, or anyone directly or indirectly employed by them or anyone for whose acts any of them may be liable, regardless of whether or not caused in part by an Indemnitee, and whether or not such claims are made by a third party or an Indemnitee; however, if an Indemnitee's negligent act or omission is subsequently determined to be the sole proximate cause of a suit or claim, the Indemnitee shall not be entitled to indemnification hereunder. Contractor shall be given timely written notice of any suit or claim. Contractor's obligations hereunder are in no way limited by any protection afforded under workers' compensation acts, disability benefits acts, or other employee benefit acts. This clause shall not negate, abridge, or reduce any other rights or obligations of indemnity which would otherwise exist. The obligations of this paragraph shall survive termination, cancelation, or expiration of the parties' agreement. This provision shall be construed fairly and reasonably, neither strongly for nor against either party, and without regard to any clause regarding insurance. As used in this clause, "Indemnitees" means the State of South Carolina, its instrumentalities, agencies, departments, boards, political subdivisions and all their respective officers, agents and employees. LICENSES AND PERMITS (JAN 2006): During the term of the contract, the Contractor shall be responsible for obtaining, and maintaining in good standing, all licenses (including professional licenses, if any), permits, inspections and related fees for each or any such licenses, permits and /or inspections required by the State, county, city or other government entity or unit to accomplish the work specified in this solicitation and the contract. PRICE ADJUSTMENTS (JAN 2006): (1) Method of Adjustment. Upon request of the Procurement Officer, the contractor shall provide reasonably available factual information to substantiate that the price or cost offered, for any price adjustments is reasonable, consistent with the provisions of Section 11-35-1830. PRICING DATA – AUDIT – INSPECTION (JAN 2006): [Clause Included Pursuant to Section 11-35-1830, - 2210, & -2220] (a) Cost or Pricing Data. Upon Procurement Officer's request, you shall submit cost or pricing data, as defined by 48 C.F.R. At reasonable times, the state may inspect any part of your place of business which is related to performance of the work. (d) Instructions Certification. When you submit data pursuant to subparagraph (a), you shall (1) do so in accordance with the instructions appearing in Table 15-2 of

48 C.F.R. Section 15.408 (2004) (adapted as necessary for the state context), and (2) submit a Certificate of Current Cost or Pricing Data, as prescribed by 48 CFR Section 15.406-2(a) (adapted as necessary for the state context). (e) Subcontracts. You shall include the above text of this clause in all of your subcontracts. (f) Nothing in this clause limits any other rights of the state. [07-7B185-1]

RELATIONSHIP OF THE PARTIES (JAN 2006): Neither party is an employee, agent, partner, or joint venturer of the other. Neither party has the right or ability to bind the other to any agreement with a third party or to incur any obligation or liability on behalf of the other party. [07-7B205-1]

SUBSTITUTIONS PROHIBITED – END PRODUCT PREFERENCES (SEP 2009): If you receive the award as a result of the South Carolina end product or United States end product preference, you may not substitute a nonqualifying end product for a qualified end product. If you violate this provision, the State may terminate your contract for cause and you may be debarred. In addition, you shall pay to the State an amount equal to twice the difference between the price paid by the State and your evaluated price for the item for which you delivered a substitute. TERM OF CONTRACT – EFFECTIVE DATE / INITIAL CONTRACT PERIOD (JAN 2006): The effective date of this contract is the first day of the Maximum Contract Period as specified on the final statement of award. The initial term of this agreement is one year from the effective date. Regardless, this contract expires no later than the last date stated on the final statement of award. [07-7B240-1]

TERMINATION FOR CONVENIENCE (JAN 2006): (1) Termination. The Procurement Officer may terminate this contract in whole or in part, for the convenience of the State. The Procurement Officer shall give written notice of the termination to the contractor specifying the part of the contract terminated and when termination becomes effective. (2) Contractor's Obligations. The contractor shall incur no further obligations in connection with the terminated work and on the date set in the notice of termination the contractor will stop work to the extent specified. The contractor shall also terminate outstanding orders and subcontracts as they relate to the terminated work. The contractor shall settle the liabilities and claims arising out of the termination of subcontracts and orders connected with the terminated work. The Procurement Officer may direct the contractor to assign the contractor's right, title, and interest under terminated orders or subcontracts to the State. The contractor must still complete the work not terminated by the notice of termination and may incur obligations as are necessary to do so. (3) Right to Supplies. The Procurement Officer may require the contractor to transfer title and deliver to the State in the manner and to the extent directed by the Procurement Officer: (a) any completed supplies; and (b) such partially completed supplies and materials, parts, tools, dies, jigs, fixtures, plans, drawings, information, and contract rights (hereinafter called "manufacturing material") as the contractor has specifically produced or specially acquired for the performance of the terminated part of this contract. The contractor shall, upon direction of the Procurement Officer, protect and preserve property in the possession of the contractor in which the State has an interest. If the Procurement Officer does not exercise this right, the contractor shall use best efforts to sell such supplies and manufacturing materials in a accordance with the standards of Uniform Commercial Code Section 2-706. Utilization of this Section in no way implies that the State has breached the contract by exercise of the Termination for Convenience Clause. (4) Compensation. (a) The contractor shall submit a termination claim specifying the amounts due because of the termination for convenience together with cost or pricing data required by Section 11-35-1830 bearing on such claim. If the contractor fails to file a termination claim within one year from the effective date of termination, the Procurement Officer may pay the contractor, if at all, an amount set in accordance with Subparagraph (c) of this Paragraph. (b) The Procurement Officer and the contractor may agree to a settlement and that the settlement does not exceed the total contract price plus settlement costs reduced by payments previously made by the State, the proceeds of any sales of supplies and manufacturing materials under Paragraph (3) of this clause, and the contract price of the work not terminated; (c) Absent complete agreement under Subparagraph (b) of this Paragraph, the Procurement Officer shall pay the contractor the following amounts, provided payments agreed to under Subparagraph (b) shall not duplicate payments under this Subparagraph: (i) contract prices for supplies or services accepted under the contract; (ii) costs reasonably incurred in performing the terminated portion of the work less amounts paid or to be paid for accepted supplies or services; (iii) reasonable costs of settling and paying claims arising out of the termination of subcontracts or orders pursuant to Paragraph (2) of this clause. These costs must not

include costs paid in accordance with Subparagraph (c)(ii) of this paragraph; (iv) any other reasonable costs that have resulted from the termination. The total sum to be paid the contractor under this Subparagraph shall not exceed the total contract price plus the reasonable settlement costs of the contractor reduced by the amount of payments otherwise made, the proceeds of any sales of supplies and manufacturing materials under Subparagraph (b) of this Paragraph, and the contract price of work not terminated. (d) Contractor must demonstrate any costs claimed, agreed to, or established under Subparagraphs (b) and (c) of this Paragraph using its standard record keeping system, provided such system is consistent with any applicable Generally Accepted Accounting Principles. (5) Contractor's failure to include an appropriate termination for convenience clause in any subcontract shall not (i) affect the State's right to require the termination of a subcontract, or (ii) increase the obligation of the State beyond what it would have been if the subcontract had contained an appropriate clause. IMPORTANT TAX NOTICE - NONRESIDENTS ONLY

Withholding Requirements for Payments to Nonresidents: Section 12-8-550 of the South Carolina Code of Laws requires persons hiring or contracting with a nonresident conducting a business or performing personal services of a temporary nature within South Carolina to withhold 2% of each payment made to the nonresident. The withholding requirement does not apply to (1) payments on purchase orders for tangible personal property when the payments are not accompanied by services to be performed in South Carolina, (2) nonresidents who are not conducting business in South Carolina, (3) nonresidents for contracts that do not exceed \$10,000 in a calendar year, or (4) payments to a nonresident who (a) registers with either the S.C. Department of Revenue or the S.C. Secretary of State and (b) submits a Nonresident Taxpayer Registration Affidavit - Income Tax Withholding, Form I-312 to the person letting the contract.

The withholding requirement applies to every governmental entity that uses a contract ("Using Entity"). Nonresidents should submit a separate copy of the Nonresident Taxpayer Registration Affidavit - Income Tax Withholding, Form I-312 to every Using Entity that makes payment to the nonresident pursuant to this solicitation. Once submitted, an affidavit is valid for all contracts between the nonresident and the Using Entity, unless the Using Entity receives notice from the Department of Revenue that the exemption from withholding has been revoked.

Section 12-8-540 requires persons making payment to a nonresident taxpayer of rentals or royalties at a rate of \$1,200.00 or more a year for the use of or for the privilege of using property in South Carolina to withhold 7% of the total of each payment made to a nonresident taxpayer who is not a corporation and 5% if the payment is made to a corporation. Contact the Department of Revenue for any applicable exceptions.
