

Clinical Assistant Professor and Director of Montessori Education

Department of Teacher Education

Applications are invited for a full-time position in the Department of Teacher Education. This nine-month position will begin on August 15, 2023. Opportunities for summer employment, including Summer 2023, are offered. As Director of Montessori Education, teaching, advising, and administrative responsibilities are required in the summer and are compensated accordingly.

Faculty responsibilities: This position requires teaching a variety of undergraduate and graduate courses, focused on Montessori education. In addition to teaching responsibilities, the faculty member works closely with PK-8 Montessori education providers, particularly public schools, throughout our region, developing innovative programs to meet their needs. The Director of Montessori ensures all Montessori programs retain current accreditation with the American Montessori Society and the Montessori Accreditation Council for Teacher Education. Advising undergraduate and graduate students in the Montessori programs is expected, as well as service to the university and in the community related to their professional area of expertise.

Required: The successful candidate will have an earned master's degree in Montessori education and must hold Montessori credentials in Early Childhood, EI, EII, or EI-EII, with at least 3 years of Montessori classroom experience at the PK-8 level. The candidate should have a record of success as a classroom teacher and demonstrate the ability to successfully develop mutually beneficial partnerships with stakeholders. Evidence of competence in teaching adults, educational administration, and/or curriculum development is required.

Preferred: Multiple Montessori credentials and earned doctorate in education preferred. Teaching experience at the university level, strong communication and interpersonal skills, and experience teaching online preferred. Successful experience with accreditation and administration preferred. Experience working with diverse students in public school settings, including but not limited to students with exceptionalities and multilingual learners, preferred. Experience serving as a supervisor for field/clinical experiences preferred.
