 - You do Not live with either parent, and
 - You do Not receive any support from either parent currently or anticipated in the future (including food & shelter, insurance, vehicle, tuition, cash, etc.) and the date that support ended, and
 - Complete all Student sections of the FAFSA and answer YES to question 8.
 - **STUDENT CERTIFICATION:** I certify that I do not live with or receive any support from either parent currently or anticipated in the future. My parents refuse to support me and refuse to submit parental information for the Free Application for Federal Student Aid (FAFSA).
