*RENEWAL CRITERIA FOR THE PALMETTO FELLOWS SCHOLARSHIP*

In order to retain the Palmetto Fellows Scholarship, you must:

- **Earn a 3.0 LANDER GPA (transfer credits are not included in the LU GPA); and**
- **Earn a minimum of 30 credit hours during EACH academic year (fall, spring, and summer terms). Transfer credit hours within the year can be used to meet this requirement.**
- **Sign an affidavit with the Financial Aid Office each year.**

**ADDITIONAL CRITERIA AND INFORMATION**

- Palmetto Fellows Scholarship recipients must be a US citizen or legal permanent resident.
- Palmetto Fellows Scholarship recipients must be a SC resident.
- Palmetto Fellows Scholarship recipients must enroll full-time (at least 12 hours per semester) in order to receive any scholarship funds. Students dropping below full-time status after the beginning of the semester may be required to return Palmetto Fellows Scholarship funds.
- Palmetto Fellows recipients are not eligible to receive the LIFE or HOPE Scholarships.
- Students receiving grant or scholarship aid in excess of tuition, fees, books, and supplies may be required to report the excess funds when filing federal and state taxes.
- Repeated coursework and developmental coursework hours will not be counted toward the enrollment status or toward the renewal criteria for Palmetto Fellows Scholars.

**CERTIFICATION INFORMATION**

State law requires that a student receiving the **Palmetto Fellows Scholarship** must certify he/she is not in default and does not owe refunds on any Federal or State financial aid, including the S.C. Need-Based Grant, Federal Pell Grant, Federal Supplemental Educational Opportunity Grant, Federal Perkins Loan, or Federal Stafford/Federal Direct Student Loan(s). This affidavit must be signed by the student. Any false information provided by the student or any attempt to obtain, expend, or attempt to expend any **Palmetto Fellows Scholarship** funds for unlawful purposes or any purpose other than in payment or reimbursement for the cost of tuition and fees and other educational costs at the institution authorized to make the scholarship will be cause for immediate cancellation of the **Palmetto Fellows Scholarship**. Any student who has obtained a **Palmetto Fellows Scholarship** through means of a willfully false statement or failure to reveal any material fact, condition, or circumstances affecting eligibility will be subject to applicable civil or criminal penalties, including the loss of the scholarship.

## APPEALS

If an extenuating circumstance has caused a student to fail to meet the academic requirements (cumulative grade point average and/or credit hours) for regaining or renewing a Palmetto Fellows Scholarship, the student may file an appeal with the Commission on Higher Education. Students wishing to file an appeal must thoroughly read the Appeal Guidelines and submit all materials by the established deadline.
