We are unable to continue processing 2026-2027 application for financial aid due to a discrepancy on your Student Aid Report. Step 1

Check your 2026-2027 Free Application for Federal Student Aid (FAFSA) to make sure the following information is correct:

- Question 30 and/or 42 - Your parent's Social Security number reported on the Student Aid Report. Your parent's last name and first initial as it appears on your Social Security Card. If he/she has changed their name (as a result of marriage, etc.), they must update their record with the Social Security Administration. Your parent's date of birth.
- Question 24, 41, 46 - Student signature (and parent's signature for a dependent student)

If these items need to be corrected, make corrections on your FAFSA using your FSA ID at <https://studentaid.gov/h/apply-for-aid/fafsa> . Be sure to have you parent sign electronically using his/her FSA ID if you are a dependent student. Alternately, you can make corrections on your paper Student Aid Report if you received one and mail it back to the Federal Processor (address listed on SAR).

Step 2

If Step 1 does not fix the issue, you and your parent can call us at 864-388-8340 and we will try to help. When you call you will need:

- **Parent's Social Security Card to confirm social security number and name.**
- **Parent's Driver's License to confirm birth date.**

In addition, your parent will need to contact the SSA to update their record to simplify the process if you apply for aid next year. Your parent can contact them by calling 1-800-772-1213 or by visiting <https://socialsecurity.gov> .
