We are unable to continue processing your 2026-2027 application for financial aid due to a discrepancy on your Free Application for Federal Student Aid (FAFSA) and the Social Security Administration (SSA) database match. Follow the instructions below to resolve the problem.

**Step 1:** Check your 2026-2027 FAFSA/Student Aid Report to make sure the following information is correct:

- Question 1:
  - Your last name, first name and middle initial as it appears on your Social Security Card. If you have changed your name (because of marriage, etc.), you must update your record with the Social Security Administration first.
  - Your Social Security number reported on the Student Aid Report.
  - Your date of birth.
- Question 29 - Your signature (and one parent's signature if you're a dependent student, Questions 41 and 46)

If these items need to be corrected, make corrections on your FAFSA using your FSA ID at <https://studentaid.gov/h/apply-for-aid/fafsa> . Be sure to have your parent sign electronically using his/her FSA ID if you are a dependent student. Alternately, you can make corrections on your paper Student Aid Report if you received one and mail it back to the Federal Processor (address listed on SAR).

**Step 2:** Please complete and return this form to the Lander University Financial Aid Office, along with:

- **A copy of your birth certificate –AND–**
- **A copy of your Social Security Card**

**In addition, you should contact the Social Security Administration to make sure that they correct their records. You can contact them by calling 1-800-772-1213 or by visiting <https://ssa.gov> .**
