## 2020-2021 Selective Service Registration Confirmation

We are unable to continue processing your 2020-2021 application for financial aid due to a discrepancy on your FAFSA/Student Aid Report. In order to be eligible for federal student aid, you must be registered with Selective Service if you are a male and are 18 through 25 years of age. The Selective Service could not confirm that you are registered with them. Follow the instructions below to resolve the problem.

**Step 1** Check your 2020-2021 FAFSA/Student Aid Report (SAR) to make sure the following information is correct:

- Questions 1-3 - Your last name, first name and middle initial (as it appears on your Social Security Card)
- Question 8 - Your Social Security number reported on the Student Aid Report
- Question 9 - Your date of birth
- Question 21 - Are you male?
- Step 7, Item 103 - Your signature (and one parent's signature if you're a dependent student)

If these items need to be corrected, make corrections on your FAFSA using your FSA ID at [www.fafsa.gov](http://www.fafsa.gov). Be sure to have your parent sign electronically using his/her FSA ID if you are a dependent student. Alternately, you can make corrections on your paper Student Aid Report if you received one and mail it back to the Federal Processor (address listed on SAR).

**If this step resolves the problem and you receive a valid FAFSA with a calculated EFC, no further action is needed. If this does not resolve the issue, proceed to Step 2.**

**Step 2** Check the category listed below that best describes your situation and take the appropriate action:

- I am a male US citizen or eligible non-citizen between the ages of 18 and 25 and have registered with Selective Service.** You will need to provide the Financial Aid Office with a copy of your registration card, a Registration Acknowledgement, or a "Quick Response Letter" from Selective Service at [www.sss.gov](http://www.sss.gov).
- I am a male US citizen or eligible non-citizen between the ages of 18 and 25 and have not registered with Selective Service.**  
You must register in order to receive federal aid. To register, you have one of the following options:
  - Complete Items 21 and 22 on your 2020-2021 FAFSA/Student Aid Report
  - Complete a Selective Service Registration form at your local post office
  - Register on-line at [www.sss.gov](http://www.sss.gov)

You will need to provide the Financial Aid Office with a copy of your registration card, a Registration Acknowledgement, or a "Quick Response Letter" from Selective Service.

- I am a male US citizen or eligible non-citizen who has reached age 26 and has not registered.**  
You must contact Selective Service at <http://www.sss.gov/Status.html> for a Status Information Letter addressing your failure to register. You must submit this document, along with a signed personal statement explaining in detail your failure to register, to the Financial Aid Office.
- I certify that I am not required to be registered with Selective Service because: (Check appropriate answer.)**  
 I am female.                       I have not reached my 18<sup>th</sup> birthday.                       I was born before 1960.  
 I am **currently** in the Armed Services on active duty. (This does not apply to members of the Reserves and National Guard who are not on active duty.)
  - **Attach a copy of your active duty military I.D. or an official letter certifying your active duty status. You must register for Selective Service once you leave active duty in order to be eligible for aid in later years.** I did not register before I turned 26 but **was** in the Armed Services on active duty prior to turning 26. (This does not apply to members of the Reserves and National Guard, and Delayed Entry Pool.)
  - **Attach a copy of your DD Form 214 "Certificate of Release or Discharge from Active Duty" (showing release under a condition other than dishonorable)** I am a citizen of the Federated States of Micronesia, the Republic of the Marshall Islands, or the Republic of Palau.  
 I am a noncitizen who entered the U.S. after I turned 26.
  - **Attach a copy of I-94, I-551 or I-551C, or your citizen certificate.** I am a noncitizen who entered the U.S. as a lawful nonimmigrant on a valid visa and remained in the U.S. under the terms of that visa until after age 26.
  - **Attach a copy of I-94, I-551 or I-551C, or your citizen certificate.**
